The BMI Fund finances an annual scholarship for studies at the Doctoral Department of HEC Paris, co-founder and primary partner of BMI. It's awarded to a student pursuing a PhD in management or a faculty member of a business school in the region. That person is enrolled in the special ISP programme for visiting scholars at HEC Paris.

I'm very pleased to note that during 2016 the first recipient of this scholarship from Lithuania successfully completed the ISP programme at HEC Paris. This one year spent at HEC Paris will of course be a significant "plus" in the academic career

of this PhD student. It is also a very good opportunity, for the many international students and professors working at HEC, to discover the high level of Lithuanian higher education.

began studies in late 2015, will finish in 2017 and includes business executives and owners from Lithuania, Belarus, Latvia and Russia. <u>90%</u> of cohort members are top managers and business owners, with an average 13 years of experience. The most highly represented industries in the group are ITT, finance, trade and logistics, followed by media, energy and pharmaceuticals. The group has a combined social network with more than 19,200 managers. They help run companies with annual revenues of about 3.75 billion euros.

The Baltic region is now part of the EU's single currency, with clear economic advantages. But more than a guarantee, the euro is an opportunity, "and now we're fully able to seize that opportunity," the central banker said. He also explained how further progress to create a single European market could bring even more benefits.

The long-time head of a major precision equipment maker led this presentation of Japanese cultural insights on management, which BMI organized with the Embassy of Japan. He described the influence of the Bushido code of the samurai, sharing many personal experiences with international and intercultural management challenges.



Effective Business Negotiations (23 MARCH)

SPEAKER: Osvaldas Čiukšys, International Negotiator

This lecture looked at keeping the initiative in negotiations in terms of the setting, team, and agenda, and using questions, emotions and suitable concessions to control the course of talks. On diverse cultures, Mr Čiukšys stressed a need to learn about each country's behaviours, values, mentality and decision-making processes.

Neuromarketing for Influence Online (19 OCTOBER)

SPEAKER: Linas Šiautkulis, CEO of BPN LT and Chairman of the Lithuanian Marketing Association

Neuroscience insights are being actively applied in e-commerce today, using words, images and different ways of arranging them to appeal to triggers in the human brain such as fight, flee, sex and food. Mr Šiautkulis described how such experiences are framed to engage website visitors' imagination and influence purchasing behaviour.

Management Control in Services (5 JANUARY)

SPEAKER: Prof. Véronique Malleret, HEC Paris [France]

Services play a growing role in business. But management control here is more complex than in manufacturing. Prof. Malleret, an expert on the topic, explained both the adaptation of traditional control methods and innovative approaches to assessing and improving the performance of service companies or service departments in companies.



Evolution of the Financial Industry (1 DECEMBER)

SPEAKER: Prof. Lars Ohnemus, CBS [Denmark]

Demographic trends, increasing regulation and FinTech startups have sparked a revolution in financial services that's likely to continue for years. Related challenges and opportunities were the topic of this lecture and discussion with BMI alumni, including executives from several banks, insurers and asset management companies.

Valuing Digital Enterprises (14 APRIL)

SPEAKER: Prof. Eamonn Walsh, UCD [Ireland]

How do you put a value on web-based companies that have millions of users but aren't yet profitable? Investors shouldn't be lured by mere "dreams", but need to analyse them like any business, Prof. Walsh stressed. Using real cases, he illustrated ways to "unpack" diverse digital business models and assess the value of such firms.

Defining an International Strategy (4 FEBRUARY)

SPEAKER: Prof. Alain Dumont, Tulane University [USA]

This lecture examined how to formulate an international strategy that is right for a specific company based on analysis of the type of international competition it faces. It was an excerpt from the "Global Strategy & Competition" course that Prof. Dumont leads in Tulane's Global MBA programme with 6 modules in 6 countries.



The USA as a Business Opportunity (3 JUNE)

SPEAKER: Prof. John Trapani, Tulane University [USA]

American consumers have kept on spending more and more despite two recessions over the past 15 years, Prof. Trapani said in this review of the U.S. economy – "an opportunity worth \$18 trillion". Even if Europe isn't the biggest trade partner, it has a special bond with the USA, he said. "We know and trust each other," he explained.

JANUARY BMI EMBA in the US

The USA module of the BMI EMBA programme took members of Class XVI to Tulane University's Freeman School of Business in New Orleans. There, with executive students from the USA and Chile, they completed courses on Managing People Internationally and Leadership.

BMI Director General Jaunius Pusvaškis and Dean for Faculty & Research, Veronique Malleret travelled to NHH Norwegian School of Economics, one of BMI's founding partner schools, in Bergen, Norway. In meetings with Rector Frøvstein Giesdal and other member of the NHH leadership, he shared BMI's experiences and discussed opportunities for further developing the two schools' valuable partnership.

APRIL New EMBA Cohort Dances into the BMI Family

MARCH BMI Contingent Gets Immersed in India

BMI students and alumni from 4 different cohorts got to know India's business climate first-hand during an 8-day module on the subcontinent organised together with Poland's Warsaw University of Technology Business School and Chandragupt Institute of Management Patna in India. This 'India Immersion Programme' included company visits, expert lectures and cultural outings in the cities of Bangalore, Mysuru and Delhi.

"We not only explored the Indian market, but also got new ideas about broader opportunities in today's global business world," said Laima Živatkauskaitė (BMI EMBA Class XVII), the Vice President of INIT Corporation and one of 9 executives from BMI who took part in the module

The newest BMI EMBA cohort – Class XVII – was officially welcomed into the BMI family of business leaders in a "christening" event organized by Class XVI and attended by members of several past cohorts. Mingling over food and drink led up to the highlight of the party: the screening and judging of dance videos made by teams from Class XVII.

Yes, dancing with passion to a pre-assigned song was this year's test of creativity for members of the new EMBA cohort. And they passed with flying colours, earning awards of all kinds by decision of the public and a distinguished jury of alumni and BMI staff.



MAY Enhanced China Module Provides Boost

EMBA Class XVII completed an upgraded module on Chinese business practices and project management at Shanghai Jiao Tong University's Antai College of Economics and Management. For the first time, lectures were led not only by top Chinese professors, but also by faculty from HEC Paris. Also for the first time, two student executives from Poland's WUT Business School joined the BMI group.

Site visits included German optical device maker Carl Zeiss AG, the Chinese headquarters of AstraZeneca, Shanghai Tunnel Engineering, and a unit of Sany Group – one of the world's 5 biggest construction equipment manufacturers.

Finland's Aalto University Hosts Innovation Module

Representatives of BMI EMBA classes VII and XVI attended a module on "Leading Innovation & Building Innovation Powerhouses" at Aalto University School of Business in Helsinki, Finland. The mobility module also included student-executives from St Petersburg State University Graduate School of Management (GSOM).

JULY Industry 4.0 Programme Initiated in Germany

BMI alumni and other executives from Germany, the Baltics, Italy, and India took part in the first edition of the "BMI Innovation & Industry 4.0 Programme" in Frankfurt. Its focus was the business implications of convergence of the physical and the virtual worlds with new forms of human-machine interaction and business intelligence.

The 35 participants visited 'smart factories' and firms set to blend virtual and physical worlds with cyber-physical systems, merging tech and business processes. They had lectures on artificial intelligence, related business models, manufacturing execution systems, and the Internet of Things.



SEPTEMBER Back-to-School Gathering with Coaching Expert

BMI held its annual 'Back-to-School' evening of knowledge and networking. The event brings potential applicants together with BMI alumni and students for an EMBA Information Session, a talk by a top international professor, and informal interaction over snacks and drinks. This year's lecturer was Aad JCM Van VLIET, an expert business coach and HR executive whose topic was "The Leader as Coach".

JUNE

Graduates Register More Than a Million Kilometres

The graduation of International Executive MBA Class XVI was attended by representatives of the BMI partner schools including HEC Paris, France and NHH, Norway as well as the business community.

"This is the BMI class that has most travelled the word, with trips totalling more than a million kilometres to attend modules in the USA, China, India, Finland, Poland and Russia," BMI Director General Jaunius Pusvaškis said. "They also gave the highest-ever approval rating of 92% to our international professors and achieved a recordhigh grade average for their master's theses," he noted.



AUGUST BMI Mobility Partners Meet at HEC Paris

BMI founder HEC Paris hosted deans from two business schools participating in BMI's Global Mobility Scheme: St Petersburg Graduate School of Management from Russia and WUT Business School from Poland. The deans met in Paris with BMI Director General Jaunius Pusvaškis to discuss executive-student exchange arrangements. Mr Pusvaškis also met with HEC Paris officials to discuss BMI's ongoing collaboration with that top global business school.

New BMI Leadership & Decision Making Programme Launches

Executives from leading Baltic, Nordic and global companies began three months of modular studies in the new "BMI Leadership & Decision-Making Programme".

Professors from the US, France, and Switzerland delivered the modules designed to give top managers the knowledge and skills to have greater impact, lead more effectively and make financially sound and commercially viable decisions. The 29 members of the first cohort had an average age of 41 and an average 17 years of business experience in business; 80% are business owners and top executives.

NOVEMBER Louvain School of Management May Add Mobility

BMI Director General Jaunius Pusvaškis visited the Belgian campus of long-time partner school Louvain School of Management. His talks with LSM leadership touched on BMI's successful experience in developing its International Executive MBA programme as well as future possibilities for executivestudent exchanges between BMI and LSM within BMI's growing Global Mobility Scheme.

Trends in Management Education in Focus

BMI Co-Chairman Prof. Jean-Paul Larçon, who long led international development at HEC Paris, gave a lecture on "Global Trends in Management Education" at the Embassy of France in Vilnius. The French-Lithuanian Chamber of Commerce organized the event with the embassy and BMI.

"Management education used to be guite local, but now the top business schools are absolutely global. You can see that at BMI, for example, which brings in top professors for each discipline from dozens of different countries and offers students a growing number of mobility or exchange opportunities around the world," Prof. Larçon noted.



BMI Alumni Experts – Lean in Practice II: How Hot Dogs and Lean Go Together EY Baltic, Vilnius (1 March)

This second meeting on Lean was led by Rasa Lapinskaitė of BMI EMBA Class XI, who is Global Process Manager at Group Finance SEB. Rasa demonstrated her black-belt expertise in Lean as she reviewed her experience working on process optimization in the pharmaceutical industry, in the European Lean Group at Statoil, and currently at SEB.

In addition to deepening their know-how on Lean implementation, participants also got a better grasp of the basics of Six Sigma methodology and the Theory of Constraints (TOC). Rasa stressed the importance of top-management involvement and how inappropriate culture "can eat the leanest strategy for breakfast". Later, over a glass of wine, participants shared their own experiences with process and quality improvement, and debated the most effective ways to prepare hot dogs at a leading fuel retailer.



BMI Alumni Experts – Lean in Practice I: Towards a Black Belt in Process Management Danske Bank, Vilnius (3 February)

More than 20 BMI alumni gathered for a presentation and discussion led by Vidas Petraitis of BMI EMBA Class X, who is a one of the most prominent Lean methodology experts in Lithuania and the head of Lean.lt. It was the first in a series of meetings on Lean.

During the event, Vidas shared his insights on the main principles of Lean, its historical roots and the development of Lean methodology. He also shared a dozen examples of the practical implementation of Lean at both manufacturing and service companies.

Participants got a better understanding of why being brave and humble is important when seeking greater efficiency and how to involve employees in order to obtain hundreds or thousands of new ideas for more effective operations and business development.



BMI Alumni Goes... Vilniaus Baldai: Lean Furniture Vilniaus Baldai, Vilnius (4 April)

The focus on Lean continued with a visit to Vilniaus Baldai, a publicly listed Lithuanian company which has risen high on furniture giant IKEA's list of worldwide suppliers. CEO Rimantas Vaitkus welcomed the BMI alumni and introduced the company. He detailed how it has developed into a cost-effective and high-quality producer and described aspects of the business model for working with a single customer like IKEA. Then he led a visit through the buzzing 51,000 sq. m. factory where participants got an up-close look at Lean production involving more than 600 employees, experiencing all the sights, sounds and smells. Finally, Alsis Boguslauskas, Head of Warehousing, elaborated further on Lean methodologies used at Vilniaus Baldai.

BMI Alumni Goes... to the Temple of Lean Thermo Fisher Scientific, Vilnius (14 June)

Imagine everything around you is organized according to the principles of Lean: walls, tables, chairs, a meeting room with clear charts and a clock on the walls, computer systems, things on your desk well-aligned, a conveniently laid out canteen... That's exactly what Thermo Fisher Scientific's offices look like!

More than a dozen BMI alumni visited the main headquarters and production site of this company, a week after Verslo Žinios named it the "Investor of the Year" and named its CEO Algimantas Markauskas the "CEO of the Year".

Shifting the company's culture to Lean had a lot to do with those achievements. Many details of that were described and shown to alumni by PPI Business System Manager Alina Štura during the site visit.



People management series of events

New Trends in HR & Leadership I: The Battle for Talent Danske Bank, Vilnius (27 April)

Kicking off a BMI Alumni series of events on new trends in HR, Jurgita Lemešiūtė-Frejienė (EMBA Class XV), an expert in recruitment, executive search and employee assessment, led an insightful session. Jurgita reviewed current challenges in the labour market, and especially the difficulties of attracting and retaining top talent. Drawing on global research data and her own experience, she offered tips in practical areas such as using social media to reach candidates, creating an attractive Employer Value Proposition that shows "what you really are", and keeping employees highly motivated and engaged. In a lively discussion, participants examined the importance of a company's image in the labour market as competition for talent heats up.

New Trends in HR & Leadership II: Authentic Leadership Danske Bank, Vilnius (17 May)

Candles, frankincense and music. Long looks into others' eyes with a focus on one's own emotions and physical changes. Open answers to the question of what you really want and long for. Reflection on states of being like balance, innovation, trust, joy, etc. This was all part of participants' experience during the second in the series of HR & Leadership events, which was led by Remigijus Savickas.

Remigijus guided the gathered BMI alumni through the Authenticity Map which is at the core of Authentic Leadership concept. The map consists of 5 five primal emotional states that create our uniqueness and each person needs to experience. But "holes" in our authenticity map left by certain situations in our life lead to synthetic behaviour and hide our true nature. "A relevant, interesting and useful theme fostering human vitality," is how Asta Dekinienė (EMBA XIV) summarized the event.

Artistic Series II: Art Collecting Kunstkamera Art Gallery, Vilnius (15 November)

Is collecting art in Lithuania a passion, duty, mission, investment or madness? That's the question Rolandas Valiunas, himself a collector of Lithuanian art, addressed in a pleasant autumn evening's discussion with BMI alumni. He presented collecting history and traditions in Lithuania and spoke about the older and newer generations of collectors. He also showed the Valiunas Ellex collection, which includes paintings, sculptures, maps, historical engravings, books and silver works by Lithuanian artists. Finally he shared interesting tips about collecting, wonderful personal stories, and even advice on avoiding mistakes.

Then Dr. Simona Makselienė, the director of the auction house Art Market Agency, spoke about trends in the art market and happenings in the Lithuanian auction market. She offered useful information about valuing and pricing works of art. In summary, it was an interesting, educational evening and pleasant for soul.



Artistic Series I: On the Theatre as Art Mažasis Teatras, Vilnius (11 October)

More than 30 BMI alumni, together with friends and relatives, gathered at the "Small Theatre" in Vilnius for the play "Pagaliau, kieno čia gyvenimas?" ("Whose life is it anyway?), in which Nijolė Normantaitė played the main role. The performance made participants ask important questions about life and value choices. Some alumni admitted that, besides laughing a lot and thinking deeply, they also shed a tear or two!

After that performance, a second and very personal one awaited: Nijolė herself, in the small BMI circle, shared stories from the theatre, her colleagues and fans, and her own personal life. She told stories from her first two books, and we were the first to hear the best stories from her third book before it came out. Those who wanted were able to obtain Nijole's books with personal dedications.





Change management series of events





Change Management I: Methodology and Gunpowder EY Baltic, Vilnius (27 October)

Amid clear changes in the political landscape and the weather, BMI Alumni launched a series of events dedicated to change management. Two dozen alumni gathered to start the series with a session led by Linas Šneideris, Senior Manager at EY Baltic, who spoke about why businesses should seek transformation, how to organize transformation programs and what that means practically for organizations and executives. The presentation laid strong methodological foundations for future visits and presentations.

Tadas Karkalas, Head of Baltic Business Strategy and Change at Danske Bank, added some gunpowder to that methodological charge, with financial and intercultural flavour, by sharing his own experiences with transformation at Danske Bank while creating a single business unit in Lithuania, Latvia and Estonia.

Change Management II: Making Utilities More Effective Wastewater Treatment Plant, Vilnius (22 November)

Continuing the change management series, this event was a case study at a wastewater treatment plant operated by the Vilniaus Vandenys water utility. After a tour of the site and presentation on its main processes, CEO Aidas Ignatavičius explained to participants how the company implemented structural changes earlier this year. The main challenges, he said, were changing the organizational culture and engaging employees and managers at all levels in order to take management quality to new level and rebuild the company's reputation in the eyes of its customers.
