Throughout 2017, BMI continued to implement its ambitious international development strategy and to constantly fine-tune its programmes in light of executives' evolving needs.

The results have been impressive: even more top international professors, modules all around the world in venues perfectly suited to the topic of study, and great global networking opportunities.

Evidence that BMI is very much on the right path include not only the high-level profiles and business achievements of participants, but also the strong ratings that participants give the programmes, modules and professors.

The enhanced Impactful Leadership & Corporate Finance Programme, for example, achieved an overall quality rating of 95% during the year. In terms of its individual modules, Impactful Negotiations was rated 94% by participants for quality, Corporate Finance for Executives was rated 98%, and Effective Leadership Now was rated 92%.

During 2017, BMI continued to add to and enhance our portfolio of unique education offerings for executives.

To begin, we renewed and upgraded the contents of the BMI Impactful Leadership & Corporate Finance Programme, also adding a choice between a European and an International option in the USA.

BMI welcomed several new professors during the year, all with impressive personal management achievements in addition to their strong academic qualifications:

During the year, we saw a continuing trend of somewhat more experienced top and senior managers and business owners joining the BMI Executive MBA. A new full group

of 50 executives began studies in the 4-continent programme late in 2017. Competition was strong for this BMI EMBA cohort (class 19), with nearly 2 applicants vying for each place.

Members of the new class have an average age of 36 years and about a third of them are women. It's noteworthy that 50% of the group have a previous master's degree and 10% in fact hold a PhD - the most ever.

The BMI 4-Continent Executive MBA is a unique programme for high-level managers and business owners designed by top business schools worldwide and delivered in North and South America, Europe and Asia.

BMI EMBA Class XVII

began studies in 2015 and finished in 2017. It includes business executives and owners from Lithuania, Belarus, Latvia and Russia. About 90% of cohort members are top managers and business owners, with an average 13 years of experience. The most highly represented industries in the group

finance.tradeandlogistics.followed by media, energy and pharmaceuticals. The group has a combined social network with more than 19,200 managers. They help run companies with annual revenues of about 3.75 billion euros.

They have an average age of 35, an average 13 years of experience and international exposure **encompassing** 58 **countries**. Among the numerous industries represented in the group, executives from ITT, finance and trade have the biggest presence, followed by manufacturing, energy and logistics. Some of the global business organizations that members of this BMI EMBA

cohortworkfor are CSC, AIG, JTI, Tikkurila, Circle K, Avon Cosmetics and Deloitte. Others help run top businesses in the Nordic-Baltic region such as ATEA, Telia, Valiunas Ellex, Euroapotheca and Danske Bank.

began studies in the second half of 2017. It includes 50 executives from Lithuania, Latvia, Estonia, Poland and Switzerland. With an average age of 36 and up to 19 years of management experience, 90% of them are top-level and senior executives. All the members of the new class have

a university degree - in fact 50% already hold a master's degree and 10% boast a PhD. Executives from industries like finance, ITT, and trade have the biggest presence in the cohort, followed by representatives of the legal profession and manufacturing, 90% similar to trends in recent years. BMI's International Recruitment Committee selected the class following a rigorous admissions process. There were nearly twice as many candidates as available places this year

Originating in a high-tech strategy of the German government, the term was first used at the Hannover Fair in 2011 and was a key focus at the Davos World Economic Forum in 2016.

Investment Management at a Central Bank (28 March)

SPEAKERS: Bank of Lithuania Chairman V. Vasiliauskas, Head of Banking Service M. Vaičiulis, and Head of Investment Management S. Galatiltis

This special session, which included a trading room visit, explored the challenges of asset management in a low interest-rate environment and how the Lithuanian central bank's investment policies are changing to ensure reasonable returns. The officials also spoke in detail about how the international financial environment is evolving and about trends like the use of computers to identify opportunities and make trading decisions automatically based on pre-set rules.



Biogenetics & Biotechnology (29 May)

SPEAKER: Adas Darinskas, PhD in Biomedical Sciences

Current rapid advances in biomedical technologies were the focus of this presentation, including the speaker's own work on stem cells for oncology and regenerative medicine, IT analysis of an individual's genome, how new technologies are revolutionizing surgery, 3D printing of organs, medical uses of nanorobots, and more. The discussion also addressed the ethical issues posed by some of the new technologies and aspects related to their commercialization.

High-Tech Potential and Policy (13 June)

SPEAKER: Vilius Šapoka, Minister of Finance of the Republic of Lithuania

Lithuania has the potential to become a serious player in global high-tech industries – especially in the areas of lasers, fintech and biotech – and the country's government aims to actively support those efforts, the minister, who is a BMI alumnus, told this gathering of executives. The state plans to do so through tax incentives and funding for initiatives to bring science and business together to innovate and commercialize new technologies, he explained.

Strategy for New Digital Businesses (18 October)

SPEAKER: Prof. Pierre Dussauge of HEC Paris, France

The development of digital technologies has been linked to the proliferation of so-called "platform businesses", which require a somewhat specific approach to strategy. This interactive session with an international authority in the field of strategy addressed some of the factors that managers and entrepreneurs running platform businesses need to pay particular attention to.



The Key Role of Self-Development (26 September)

SPEAKER: Saulius Jovaišas, Certified Executive Coach

A central part of any manager's job is to always keep developing them self, since only then will they be able to help other people develop. "We're simply not able to help our employees grow if we're not trying to grow ourselves," said Mr. Jovaišas, a 2009 graduate of the BMI EMBA. He reviewed key leadership and emotional competence qualities, stressing the importance of clarifying what really motivates you, and doing so honestly, as a guide for daily work.



Coping with Organizational Crisis (13 December)

SPEAKER: Prof. Jan Freidank of THM Business School, Germany

With disruptive changes and the fast spread of news becoming ever more frequent business challenges, crisis management has become a crucial skill for top managers. The lecturer used business cases, including the recent VW diesel scandal, to discuss possible response strategies to different crisis scenarios. In any case, he stressed, "what you need is to say the truth, be open, direct, fast and honest to successfully cope with an organizational crisis."

Tech Trends, Disruption and Transformation (8 June)

SPEAKER: Prof. Shirish C. Srivastava of HEC Paris, France

BMI's new professor of digital management led a lecture and discussion for alumni on global tech trends, how they're disrupting industries, and how to leverage such disruption as business opportunities. He addressed trends like the intelligent platforms and objects emerging from advances in Al and machine learning, dynamic connection of people, processes and things in digital ecosystems, and adaptive security architecture to manage evolving digital risks. In this context, business models have to be reinvented as key success factors change, buying products is replaced by using services, and collaborative production and ecosystems become the norm. The BMI Alumni Upgrade Programme offers graduates regular opportunities to extend the valuable knowledge they got in the BMI EMBA, and also to network.

Digitalization and its Impact on the Economy and Society

(15 February)

SPEAKERS: Mindaugas Sinkevičius, Minister of Economy; Johan Dennelind, CEO of Telia Company; Šarūnas Chomentauskas, CEO of Exacaster

MODERATOR: Ilja Laurs, Founder and Chairman of Nextury Ventures

Business and government leaders gathered at BMI for a fundamental discussion of economic and social aspects of the ongoing digital revolution. It was broadcast live on Delfi TV. The high-level panel noted that the Nordic-Baltic region has the talent and infrastructure to take a leading role in the emerging digital society. Speakers stressed the importance of open partnership and collaboration in developing new technologies, ways to ensure "digital equality" and ensure no part of society is left out. Chinese Ambassador to Lithuania Wei Ruixing agreed and urged business leaders and policy-makers not to focus on bigger or smaller geographical regions, but rather to think in global terms.

BMI student-executives attend USA module

The module included lectures on cross-cultural leadership and strategy by top Chinese and European professors, a team project with Chinese managers, site visits to major companies in the Shanghai area, and a final networking event with dozens of China-based alumni of BMI partner school HEC Paris. Also valuable was a round-table on China's new Belt

& Road Initiative, the huge international trade and infrastructure project which the Chinese state is actively promoting. The session was led by Prof. Jean-Paul Larçon, BMI's Co-Chairman, who is an expert on the topic.



German executives explore Baltics with BMI

A diverse group of German executives spent a week at BMI for a complement to the "Innovation & Industry 4.0" programme which BMI delivers in Frankfurt. They represented automotive giants Continental AG, Hyundai and Küster Group, the communications technology firm Ascom, Complan & Partner – a provider of ERP solutions for the age of Industry 4.0, and the credit-rating agency Creditreform. 



Presentations that win against smartphones
